### Northwest Sub-Regional Planning Study

The City of Fort Worth will be partnering North Central Texas Council of Governments (NCTCOG) to develop a Sub-Regional Transportation Plan for the rapidly growing areas west and north in and near Fort Worth.

The purpose of this plan is to create a multi-jurisdictional planning document that establishes a regional multitransportation arterial and network framework for prioritization and implementation of improvements. The plan will emphasize development of a variety of transportation network alternatives, coupled with an overview of how land in the area can be best used along in conjunction with area redevelopment. The Study will result in a shared vision for mobility across the fastest growing portions of the north western side of the Metroplex.

### **Citywide Transportation Masterplan**

The Plan will be developed in close coordination with NCTCOG, local jurisdictions and Texas Department of Transportation (TxDOT). The Plan is anticipated to provide common goals and implementation processes across city departments, associated transit agencies and other partners on performance of current and future major mobility projects, and will:

- 1. Develop clear goals and objectives for city transportation investments over next 25 years.
- 2. Support the city's commitment to vision zero and equity.
- 3. Support a state of good repair and fiscal responsibility.
- 4. Support the city's comprehensive plan and NCTOG's Metropolitan Transportation Plan.
- 5. Prioritize feedback from the public during the plan's public outreach and engagement process.
- 6. Develop a program of multimodal projects tied back to bond, TIP, and other funding cycles.
- 7. Sync the existing transpiration network planning documents into a comprehensive multimodal network (thoroughfares, active transportation, transit)
- 8. Coordinate city policies that impact transportation and land use, such as zoning and subdivision regulation.
- 9. Integrate smart cities and technology strategies with viable projects and policies for programming and implementation of plan goals.
